

# Governor's Newsletter. Spring Term 2024

## **Social Media and Pupil Behaviour**

At our recent Full Governing Board Meeting we discussed the impact of social media and online gaming on the behaviour of some pupils. Recently the school has had to deal with some extremely poor and challenging behaviour, from a small group of pupils, as a result of inappropriate interactions on social media and gaming platforms. Unfortunately, while these interactions happen out of school hours, the fallout in terms of aggression and anxiety is being brought into school. Senior leaders and staff are having to manage unacceptable behaviour from pupils, which is not a direct result of the pupils' experiences during the school day. I am sure you can appreciate that the main responsibility for overseeing and managing pupils' interaction with social media and gaming platforms is with you as parents and not the school.

As governors, therefore, we are asking parents to support the school by ensuring you appropriately oversee and monitor your children's access to and use of social media and gaming platforms. The school provides parents with access to advice and support via it's

E-Safety Help page on the school website. There is also a link to the Safer Internet website. All parents are expected to abide by the Home-School Agreement, which does refer to your responsibility for overseeing your child's general behaviour and online safety.

The school will continue to work with parents to ensure children and families are given advice and support on how to manage social media and online gaming platforms. Governors are asking parents to continue to work with and support the school by being vigilant about overseeing and monitoring their children's online experiences.
